Description

TEMT1000 is a high speed and high sensitive silicon NPN epitaxial planar phototransistor in SMT package with dome lens. Due to its integrated Daylight filter the device is sensitive for IR radiation only.


High on axis sensitivity is provided by a viewing angle of \pm 15°.




Figure 1. Collector Dark Current vs. Ambient Temperature




Figure 2. Relative Collector Current vs. Ambient Temperature




Figure 3. Collector Emitter Capacitance vs. Collector Emitter Voltage




Figure 4. Relative Radiant Sensitivity vs. Angular Displacement






Figure 5. Turn On/Turn Off Time vs. Collector Current

Ozone Depleting Substances Policy Statement

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.
- 2. Regularly and continuously improve the performance of our products, processes, distribution and operating systems with respect to their impact on the health and safety of our employees and the public, as well as their impact on the environment.

- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
