






Figure 2. Typ. Forward Current vs. Forward Voltage




Figure 3. Max. Peak Forward Surge Current vs. Number of Cycles





Figure 4. Typ. Diode Capacitance vs. Reverse Voltage




Telcent of Maleu Teak Reverse Voltage (70)
