





Figure 2. Max. Average Forward Current vs. Ambient Temperature




Figure 4. Reverse Recovery Charge vs. Forward Current





Figure 5. Reverse Recovery Time for I_{RM} vs. Forward Current Rate of Change



- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
