




Fig.1 Ground emitter output characteristics




Fig.2 Ground emitter propagation characteristics




Fig.3 DC current gain vs. collector current





Fig.4 Collector-emitter saturation voltage Fig.5 Resistance ratio vs. collector current vs. collector current






Fig.6 Collector output capacitance vs. collector-base voltage




Fig.7 Safe operating area
