# Description

BPV10 is a very high speed and high sensitive PIN photodiode in a standard  $T-1\frac{3}{4}$  plastic package. Due to its waterclear epoxy the device is sensitive to visible and infrared radiation.




Figure 2. Relative Reverse Light Current vs. Ambient Temperature






Figure 3. Reverse Light Current vs. Irradiance




Figure 4. Reverse Light Current vs. Reverse Voltage




Figure 5. Diode Capacitance vs. Reverse Voltage




Figure 6. Relative Spectral Sensitivity vs. Wavelength




Figure 7. Relative Radiant Sensitivity vs. Angular Displacement



- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
