


Backlighting Blue LED, Ø 3 mm Tinted Non-Diffused Package

Description

The TLVB4200 series was developed for backlighting. Due to its special shape the spatial distribution of the radiation is qualified for backlighting.

To optimize the brightness of backlighting a custombuilt reflector (with scattering) is required. Uniform illumination can be enhanced by covering the front of the reflector with diffusor material.

This is a flexible solution for backlighting different areas.




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature for InGaN






Figure 3. Forward Current vs. Forward Voltage




Figure 5. Relative Luminous Flux vs. Forward Current




Figure 4. Rel. Luminous Flux vs. Ambient Temperature




Figure 6. Relative Intensity vs. Wavelength





Figure 7. Rel. Luminous Intensity vs. Angular Displacement for 90 $^{\circ}$ Emission Angle


