




Forward Current vs. Collector Dissipation Temperature Rating




Light Current vs. Collector–Emitter Voltage Characteristics (Typical)




**Response Time vs. Load Resistance Characteristics (Typical)** 




Forward Current vs. Forward Voltage Characteristics (Typical)




Relative Light Current vs. Ambient Temperature Characteristics (Typical)









## Light Current vs. Forward Current Characteristics (Typical)
