



Figure 1. Functional diagram





Figure 5. Junction capacitance versus reverse voltage applied (typical values)







Figure 6. Relative variation of leakage current versus junction temperature (typical values)

Figure 7. S21 attenuation measurement result






Figure 8. ESD response to IEC 61000-4-2 (+2 kV air discharge)

Figure 11. ESD response to IEC 61000-4-2 (-8 kV air discharge)





Figure 12. ESD response to IEC 61000-4-2 (+15 kV air discharge)

Figure 15. ESD response to IEC 61000-4-2 (-2 kV contact discharge)




Figure 16. ESD response to IEC 61000-4-2 (+8 kV contact discharge)

Figure 17. ESD response to IEC 61000-4-2 (-8 kV contact discharge)





Figure 18. ESD response to IEC 61000-4-2 (+15 kV contact discharge)


Figure 19. ESD response to IEC 61000-4-2 (-15kV contact discharge)





Figure 21. Footprint


Figure 22. Marking







Figure 25. Tape and reel specifications

4 Recommendation on PCB assembly

4.1 Stencil opening design

- 1. General recommendation on stencil opening design
 - a) Stencil opening dimensions: L (Length), W (Width), T (Thickness).

b) General design rule


Stencil thickness (T) = 75 \sim 125 μm

Aspect Ratio =
$$\frac{W}{T} \ge 1.5$$

Aspect Area =
$$\frac{L \times W}{2T(L+W)} \ge 0.66$$

- 2. Reference design
 - a) Stencil opening thickness: 100 µm
 - b) Stencil opening for leads: Opening to footprint ratio between 60% and 65%.

4.2 Solder paste

- 1. Halide-free flux qualification ROL0 according to ANSI/J-STD-004.
- 2. "No clean" solder paste is recommended.
- 3. Offers a high tack force to resist component movement during high speed
- 4. Solder paste with fine particles: powder particle size is 20-45 μm.

4.3 **Placement**

- Manual positioning is not recommended.
- 2. It is recommended to use the lead recognition capabilities of the placement system, not the outline centering
- Standard tolerance of + 0.05 mm is recommended. 3.
- 3.5 N placement force is recommended. Too much placement force can lead to squeezed out solder paste and cause solder joints to short. Too low placement force can lead to insufficient contact between package and solder paste that could cause open solder joints or badly centered packages.
- To improve the package placement accuracy, a bottom side optical control should be performed with a high resolution tool.
- For assembly, a perfect supporting of the PCB (all the more on flexible PCB) is recommended during solder paste printing, pick and place and reflow soldering by using optimized tools.

4.4 PCB design preference

- To control the solder paste amount, the closed via is recommended instead of open
- The position of tracks and open vias in the solder area should be well balanced. The symmetrical layout is recommended, in case any tilt phenomena caused by asymmetrical solder paste amount due to the solder flow away.

4.5 Reflow profile




Figure 28. ST ECOPACK® recommended soldering reflow profile for PCB mounting
