




Forward Current vs. Collector




Forward Current vs. Forward Voltage Characteristics (Typical)




LED Current vs. Supply Voltage (Typical)




LED Current vs. Ambient **Temperature Characteristics** (Typical)




Low-level Output Voltage vs. Output Current (Typical)




Low-level Output Voltage vs. Ambient Temperature Characteristics (Typical)




Current Consumption vs. Supply Voltage (Typical)
