




Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature




Figure 3. Forward Current vs. Pulse Length




Figure 4. Rel. Luminous Intensity vs. Angular Displacement




Figure 5. Percentage Total Luminous Flux vs.
Total Included Angle (Degrees)





Figure 6. Thermal Resistance Junction Ambient vs.
