
- Soldering temperature: 260°Cmax soldering time: 3s max (Soldering portion of lead: Up to 2mm from the body of the device)

- This visible LED lamp also emits some IR light. If a photodetector is located near the LED lamp, please ensure that it will not be affected by this IR light.












Radiation Pattern
