



Figure 1. Functional diagram



Figure 4. Response to ISO 7637-2 Pulse 3b on each channel




Figure 5. ESD response to ISO10605 - C = 150 pF, R = 330 Ω (+25 kV air discharge) on each channel

Figure 6. ESD response to ISO10605 - C = 150 pF, R = 330 Ω (-25 kV air discharge) on each channel




Figure 7. Peak pulse power dissipation versus initial junction temperature (maximum values)

Figure 8. Peak pulse power dissipation versus pulse duration (maximum values)





Figure 9. Clamping voltage versus peak pulse current (typical values, exponential waveform 8/20 µs)

Figure 10. Junction capacitance versus reverse voltage applied (typical values)








Figure 11. Leakage current versus junction temperature (typical values)

Figure 12. S21 attenuation measurement results of each channel







Figure 13. Ordering information scheme


