


Figure 1. Power Dissipation vs. Ambient Temperature




Figure 2. Forward Current vs. Ambient Temperature






Figure 3. Pulse Forward Current vs. Pulse Duration




Figure 4. Forward Current vs. Forward Voltage




Figure 5. Radiant Intensity vs. Forward Pulse Current




Figure 6. Relative Radiant Power vs. Wavelength





Figure 7. Relative Radiant Intensity vs. Angular Displacement

Temperature - Time Profile




Figure 8. Lead Tin (SnPb) Reflow Solder Profile




Figure 9. Blister Tape

Drypack

Devices are packed in moisture barrier bags (MBB) to prevent the products from moisture absorption during transportation and storage. Each bag contains a desiccant.

Floor Life

Floor life (time between soldering and removing from MBB) must not exceed the time indicated in J-STD-020. TSM... is released for:
Moisture Sensitivity Level 2, according to

JEDEC, J-STD-020 Floor Life: 1 year

Conditions: T_{amb} < 30 °C, RH < 60 %




Figure 10. Tape Dimensions in mm for PLCC-2

Drying

In case of moisture absorption devices should be baked before soldering. Conditions see J-STD-020 or Label. Devices taped on reel dry using recommended conditions 192 h @ 40 $^{\circ}$ C (+ 5 $^{\circ}$ C), RH < 5 $^{\circ}$

Missing Devices

Tape leader

A maximum of 0.5 % of the total number of components per reel may be missing, exclusively missing components at the beginning and at the end of the reel. A maximum of three consecutive components may be missing, provided this gap is followed by six consecutive components.

Carrier trailer

The tape leader is at least 160 mm and is followed by a carrier tape leader with at least 40 empty compartements. The tape leader may include the carrier tape as long as the cover tape is not connected to the carrier tape. The least comoponent is followed by a carrier tape trailer with a least 75 empty compartements and sealed with cover tape.




Figure 12. Dimensions of Reel

Cover Tape Removal Force

The removal force lies between 0.1 N and 1.0 N at a removal speed of 5 mm/s. In order to prevent components from popping out of the bliesters, the cover tape must be pulled off at an angle of 180 ° with regard to the feed direction.
