





F Typical Inductance vs. Current Characteristics:

After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

- •All products are supposed to be used before the end of the period of 12 months based on the product date-code, if not a 100% solderability can't be warranted.
- Violation of the technical product specifications such as exceeding the nominal rated current will result in the loss of warranty.
- •Due to heavy weight of the components of size 2212, strong forces and high accelerations might have the effect to damage the electrical connection or to harm the circuit board and will result in the loss of warranty.
