




The TSOP4038 is a compact IR receiver for sensor applications. It has a high gain for IR signals at 38 kHz. The detection level does not change when ambient light or strong IR signals are applied. It can receive continuous 38 kHz signals or 38 kHz bursts.

### **APPLICATION CIRCUIT**



The external components R $_1$  and C $_1$  are optional to improve the robustness against electrical overstress (typical values are R $_1$  = 100  $\Omega$ , C $_1$  = 0.1  $\mu$ F).

The output voltage  $V_{\rm o}$  should not be pulled down to a level below 1 V by the external circuit.

The capacitive load at the output should be less than 2 nF.




Fig. 1 - Output Active Low





Fig. 2 - Pulse Length and Sensitivity in Dark Ambient






Fig. 3 - Output Function




Fig. 4 - Output Pulse Diagram




Fig. 5 - Frequency Dependence of Responsivity




Fig. 6 - Sensitivity vs. Supply Voltage Disturbances




Fig. 7 - Sensitivity vs. Electric Field Disturbances




Fig. 8 - Sensitivity vs. Ambient Temperature




Fig. 9 - Relative Spectral Sensitivity vs. Wavelength




Fig. 10 - Directivity





Fig. 11 - Sensitivity vs. Supply Voltage
