# SKY12232-21: High IIP3 2.65-3.65 GHz Voltage-Controlled Variable Attenuator

## **Applications**




Figure 1. SKY12232-21 Block Diagram

#### **Description**

The SKY12232-21 is a voltage-controlled variable attenuator from Skyworks series of high 3<sup>rd</sup> Order Input Intercept Point (IIP3) components. The device has been designed to operate over the 2.65 to 3.65 GHz frequency band, but is specifically optimized for use as a wide dynamic range, low distortion attenuator, centered at 3.1 GHz.

The SKY12232-21 provides monotonic attenuation performance over its entire control voltage range. This attenuator is comprised of a pair of matched PIN diodes that terminate two ports of its internal 90-degree hybrid coupler. The diodes are biased using an external control voltage signal. The attenuator requires no external components. It operates with a control voltage range of 0 to 5 V and a 1.7 mA typical control current at maximum attenuation.




Figure 2. SKY12232-21 Pinout – 8-Pin MCM (Top View)

A functional block diagram is shown in Figure 1. The pin configuration and package are shown in Figure 2. Signal pin assignments and functional pin descriptions are provided in Table 1.

#### **Technical Description**

The SKY12232-21 is a 50  $\Omega$  matched voltage-controlled variable attenuator with monotonic attenuation performance from 2.65 to 3.65 GHz over its entire control voltage range. This attenuator requires no external biasing or RF matching components.

Monotonic performance means the attenuation increases as the applied DC voltage increases. This attenuator is comprised of a pair of matched PIN diodes that terminate two ports of an internal 90-degree hybrid coupler.

The diodes are biased using an external control voltage signal that sets the bias current through a resistive network. The attenuator operates with a control voltage range of 0 to 5 V and a 1.7 mA typical control current at maximum attenuation. As the control voltage increases, the bias current through each of the PIN diodes also increases. This increased bias current lowers the resistance of the PIN diodes. Maximum attenuation occurs when the resistance of the PIN diodes equals the characteristic impedance of the hybrid coupler ports, which they terminate. This occurs at a control voltage of approximately 5 VDC.

#### **Electrical and Mechanical Specifications**

The absolute maximum ratings of the SKY12232-21 are provided in Table 2. Electrical specifications are provided in Table 3.




Figure 3. Attenuation vs Frequency Over Control Voltage

Performance characteristics for the SKY12232-21 are illustrated in Figures 3 through 8.




Figure 5. Attenuation Flatness vs Control Voltage (f = 2.65 to 3.65 GHz)




Figure 4. Attenuation vs Control Voltage Over Temperature (f = 3.1 GHz)




Figure 6. Current vs Control Voltage Over Temperature




Figure 7. Input Return Loss vs Frequency Over Control Voltage




Figure 8. Output Return Loss vs Frequency Over Control Voltage

#### **Evaluation Board Description**

The SKY12232-21 Evaluation Board is used to test the performance of the SKY12232-21 variable attenuator. An assembly drawing for the Evaluation Board is shown in Figure 9. The Evaluation Board layer detail is shown in Figure 10.

The attenuation level of the SKY12232-21 is controlled by applying 0 to 5 V to the V\_CONTROL pins.

#### **Package Dimensions**



## **Package and Handling Information**


Instructions on the shipping container label regarding exposure to moisture after the container seal is broken must be followed. Otherwise, problems related to moisture absorption may occur when the part is subjected to high temperature during solder assembly.

THE SKY12232-21 is rated to Moisture Sensitivity Level 1 (MSL1) at 260 °C. It can be used for lead or lead-free soldering. For additional information, refer to the Skyworks Application Note, *PCB Design & SMT Assembly/Rework Guidelines for MCM-L Packages*, document number 101752.

Care must be taken when attaching this product, whether it is done manually or in a production solder reflow environment. Production quantities of this product are shipped in a standard tape and reel format.











Figure 13. SKY12232-21 8-Pin MCM Package Dimensions




Figure 14. SKY12232-21 Tape and Reel Dimensions
