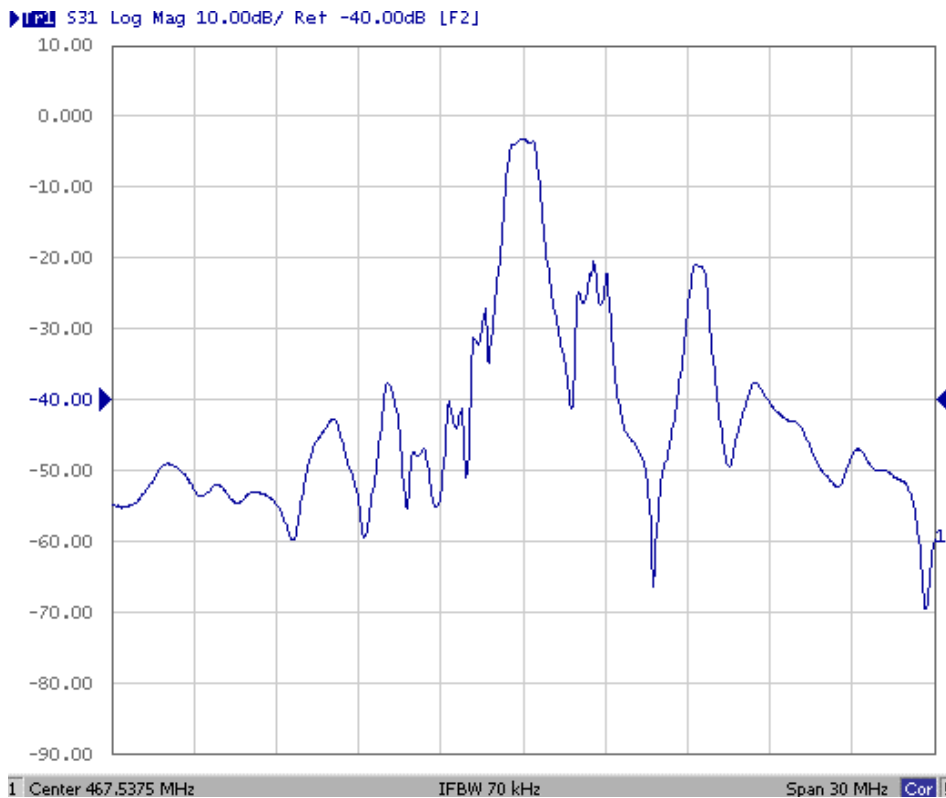

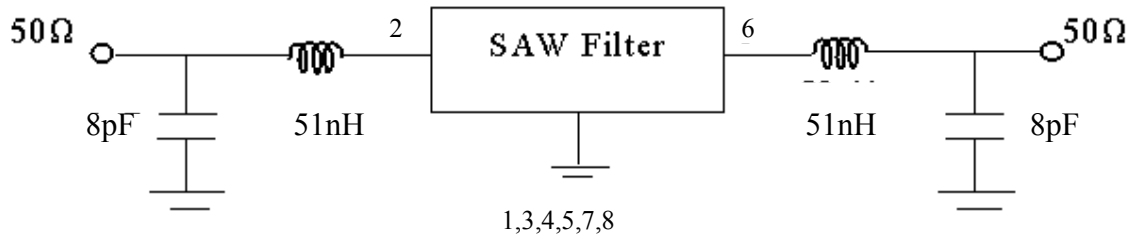

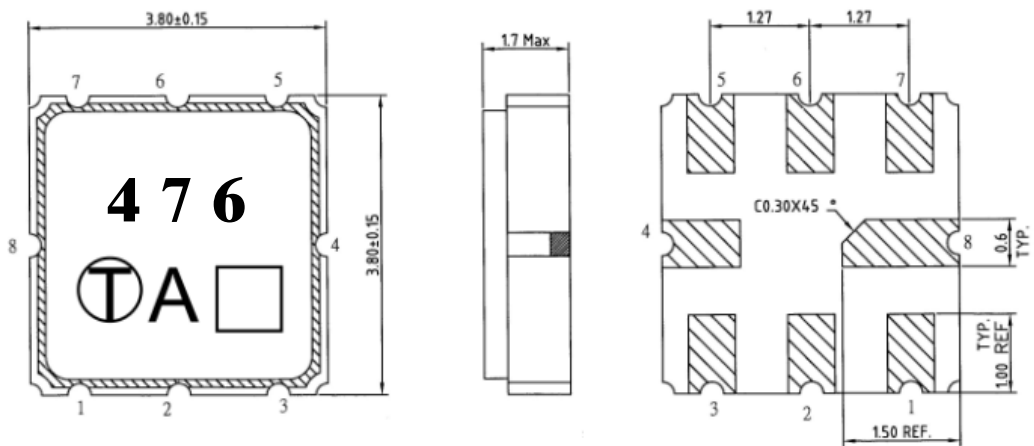


**D. MEASUREMENT CIRCUIT:**

HP Network analyzer

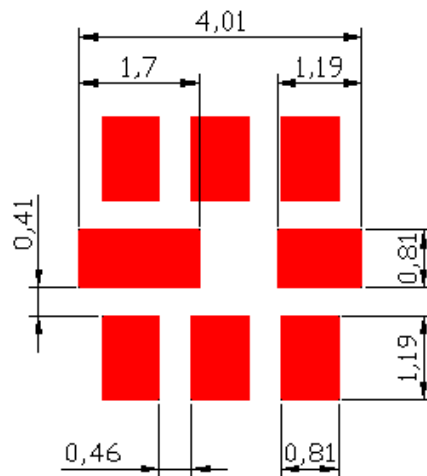

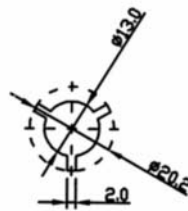
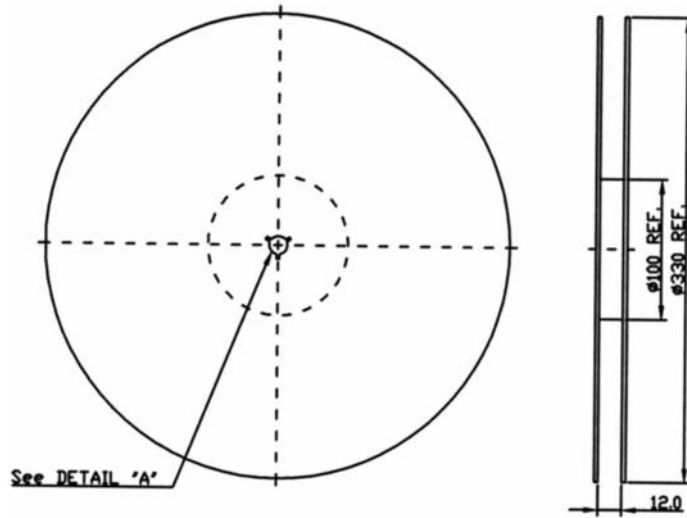
