

#### 2. Features

- (1) Small footprint due to a small and thin package
- (2) Low drain-source on-resistance:  $R_{DS(ON)} = 2.0 \text{ m}\Omega$  (typ.) ( $V_{GS} = 10 \text{ V}$ )
- (3) Low leakage current:  $I_{DSS} = 10 \mu A \text{ (max) (V}_{DS} = 30 \text{ V)}$
- (4) Enhancement mode:  $V_{th}$  = 1.3 to 2.3 V ( $V_{DS}$  = 10 V,  $I_D$  = 0.5 mA)






Fig. 5.1 Device Mounted on a Glass-Epoxy Board (a)




Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking




Fig. 8.1 I<sub>D</sub> - V<sub>DS</sub>




Fig. 8.3 ID - VGS




Fig. 8.5 R<sub>DS(ON)</sub> - I<sub>D</sub>




Fig. 8.2 I<sub>D</sub> - V<sub>DS</sub>




Fig. 8.4 V<sub>DS</sub> - V<sub>GS</sub>




Fig. 8.6 R<sub>DS(ON)</sub> - T<sub>a</sub>




Fig. 8.7 I<sub>DR</sub> - V<sub>DS</sub>




Fig. 8.9 V<sub>th</sub> - T<sub>a</sub>




Fig. 8.11 P<sub>D</sub> - T<sub>a</sub> (Guaranteed Maximum)




Fig. 8.8 Capacitance - V<sub>DS</sub>




Fig. 8.10 Dynamic Input/Output Characteristics




Fig. 8.12 P<sub>D</sub> - T<sub>c</sub> (Guaranteed Maximum)




Fig. 8.13  $r_{th}$  -  $t_w$  (Guaranteed Maximum)





Fig. 8.14 Safe Operating Area (Guaranteed Maximum)
