


### 7. Test information

### 7.1 Ruggedness in class-AB operation

The BLF10M6200 and BLF10M6LS200 are enhanced rugged devices and capable of withstanding a load mismatch corresponding to VSWR = 10 : 1 through all phases under the following conditions:  $V_{DS} = 28 \text{ V}$ ;  $I_{Dq} = 1400 \text{ mA}$ ;  $P_L = 200 \text{ W}$ ; f = 894 MHz

Fig 2. Component layout








Fig 4. Power gain and drain efficiency as function of peak envelope power load power; typical values



 $V_{DS}$  = 28 V;  $I_{Dq}$  = 1400 mA; f = 881 MHz (± 100 kHz).


Fig 5. Intermodulation distortion as a function of peak envelope power load power; typical values





Fig 8. Package outline SOT502A
