




Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking






Fig. 8.1 I_D - V_{DS}

Drain current I_D (A) Fig. 8.5 $R_{DS(ON)}$ - I_D




Fig. 8.2 I_D - V_{DS}




Fig. 8.4 V_{DS} - V_{GS}




Fig. 8.6 R_{DS(ON)} - T_a




Fig. 8.7 I_{DR} - V_{DS}




Fig. 8.9 V_{th} - T_a




Fig. 8.11 P_D - T_c (Guaranteed Maximum)




Fig. 8.8 Capacitance - V_{DS}




Fig. 8.10 Dynamic Input/Output Characteristics





Fig. 8.12 $r_{th}/R_{th(ch-c)} - t_w$ (Guaranteed Maximum)




Fig. 8.14 EAS - Tch (Guaranteed Maximum)





Fig. 8.15 Test Circuit/Waveform
