




PERFORMANCE CURVES













MAXIMUM SAFE OPERATING AREA



DRAIN-SOURCE VOLTAGE VDs (V)


OUTPUT CHARACTERISTICS (TYPICAL)









DRAIN CURRENT ID (A)



FORWARD TRANSFER ADMITTANCE **VS.DRAIN CURRENT**






