These SoCs support integrated broadcast and broadband services, combined with the latest set-top box middleware and broadband software solutions.

ST's Faroudja[®] transcode engine provides bestin-class transcoding capabilities for multi-screen streaming across consumer and handheld devices. This allows operators to optimize network bandwidth, while offering an excellent quality of service throughout the home.

The STiH410 supports HEVC decoding, and therefore permits IP service providers a means of offering HD content to a greater number of customers.
