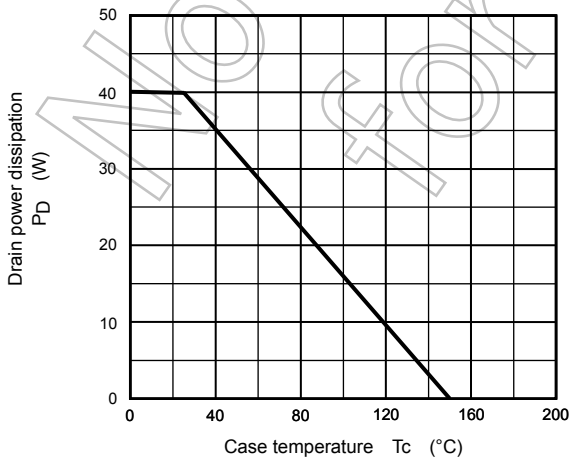
Capacitance -  $V_{DS}$



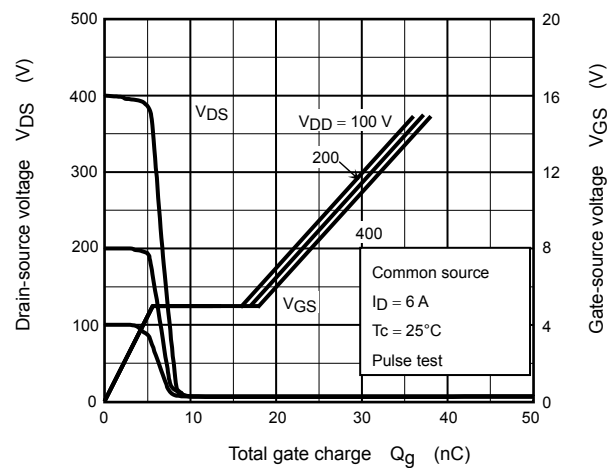
