DESCRIPTION

The UT54ACTS157E is a monolithic data selector/multiplexer. A 4-bit word is selected from one of two sources and is routed to the four outputs. A separate strobe input, \overline{G} , is provided.

The device is characterized over full HiRel temperature range of -55 $^{\circ}$ C to +125 $^{\circ}$ C.





16-Lead Flatpack Top View




