1. General description

The NCX2200 provides a single low voltage, low power, comparator.

The NCX2200 has a very low supply current of 6 μ A and is guaranteed to operate at a low voltage of 1.3 V and is fully operational up to 5.5 V. These characteristics make the device convenient for use in both 3.0 V and 5.0 V systems.




6. Functional diagram





Fig 5. Supply current versus temperature





Fig 6. Supply current versus output transition frequency




Fig 7. Supply current versus supply voltage



Fig 9. LOW-level output voltage versus output current






13. Application information

13.1 Operating description

The NCX2200 is a single low voltage, low power, comparator. This device is designed for rail-to-rail input and output performance. This device consumes only 6 μ A of supply current while achieving a typical propagation delay of 0.8 µs at a 20 mV input overdrive. This comparator is guaranteed to operate at a low voltage of 1.3 V up to 5.5 V. The common-mode input voltage range extends 0.1 V beyond the upper and lower rail without phase inversion or other adverse effects. This device has a typical internal hysteresis of 9.0 mV. This allows for greater noise immunity and clean output switching.

13.2 Output stage




Fig 14. NCX2200 complementary output configuration

The NCX2200 has a complementary P and N Channel output stage that has capability of driving a rail-to-rail output swing with a load ranging up to 5.0 mA. It is designed such that shoot-through current is minimized while switching. This feature eliminates the need for bypass capacitors under most circumstances. See Figure 14





Fig 15. Schmitt trigger oscillator








Fig 20. Package outline SOT886 (XSON6)




Fig 21. Package outline SOT891 (XSON6)
