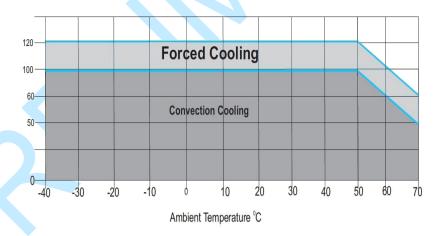

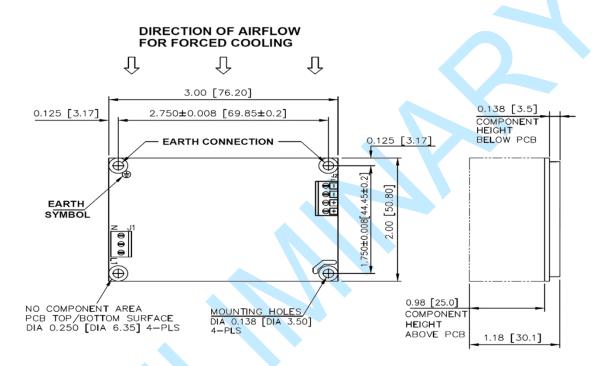

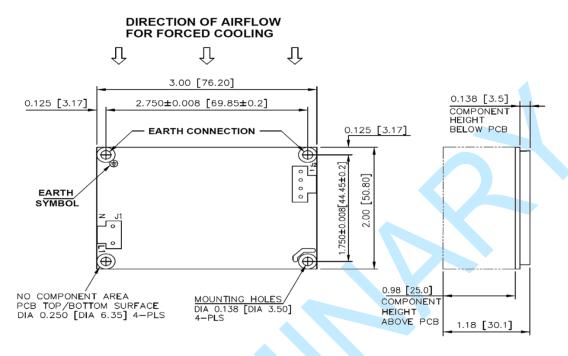
Figure 2 - Mechanical Drawing - Screw Terminal (Option 1)
