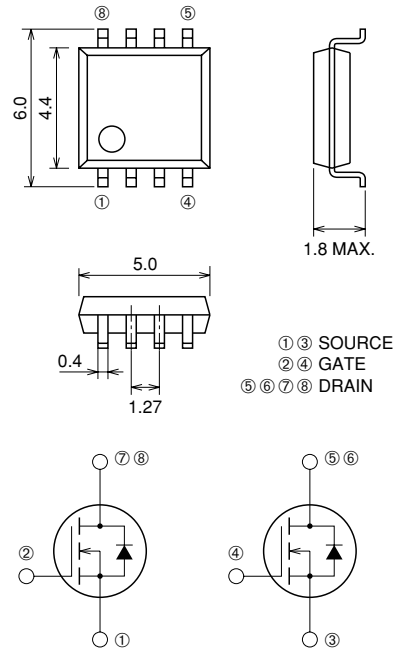

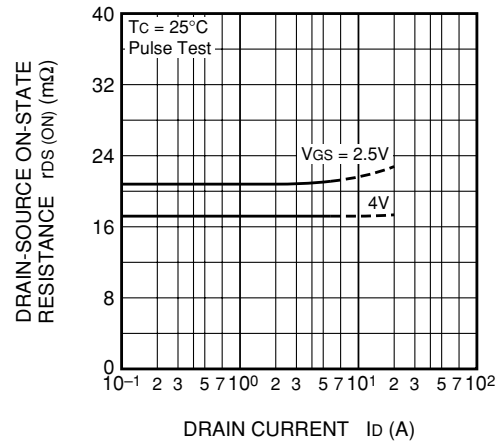

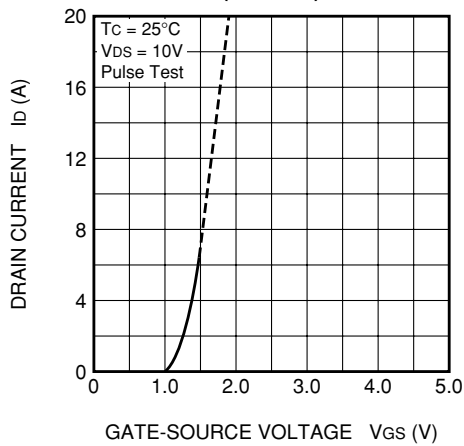
ON-STATE VOLTAGE VS.

(TYPICAL)



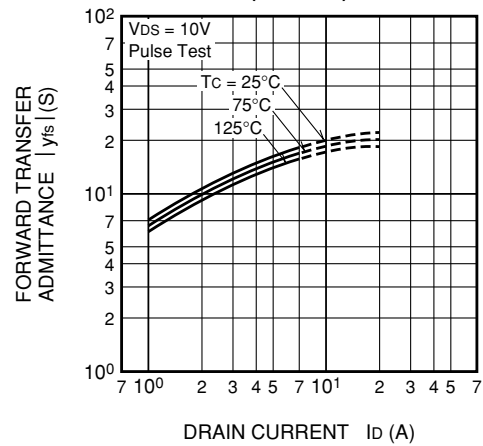
ON-STATE RESISTANCE VS.

(TYPICAL)



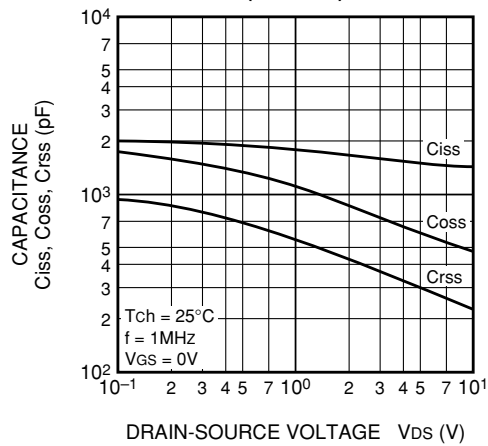
TRANSFER CHARACTERISTICS
(TYPICAL)



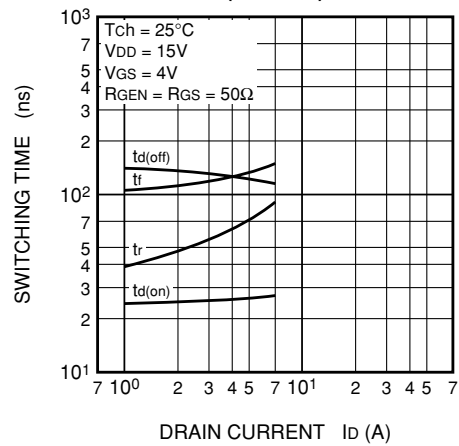
FORWARD TRANSFER ADMITTANCE

(TYPICAL)



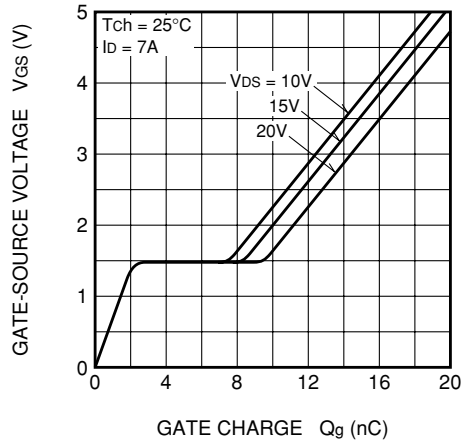
CAPACITANCE VS.

(TYPICAL)



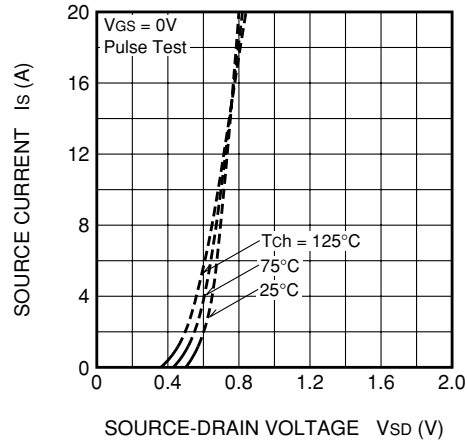
SWITCHING CHARACTERISTICS
(TYPICAL)



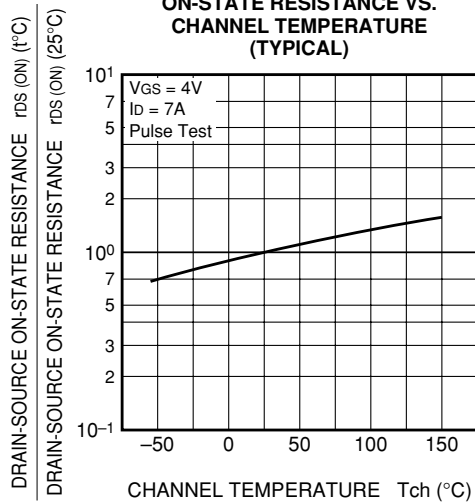
GATE-SOURCE VOLTAGE

(TYPICAL)



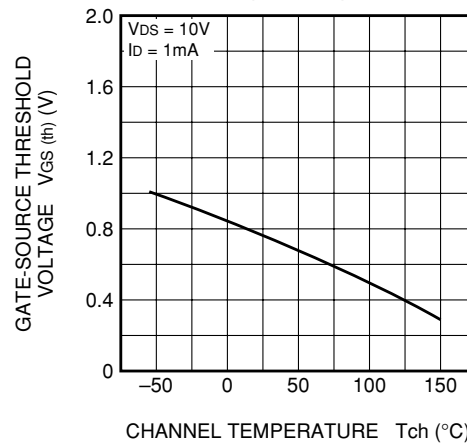
SOURCE-DRAIN DIODE

(TYPICAL)



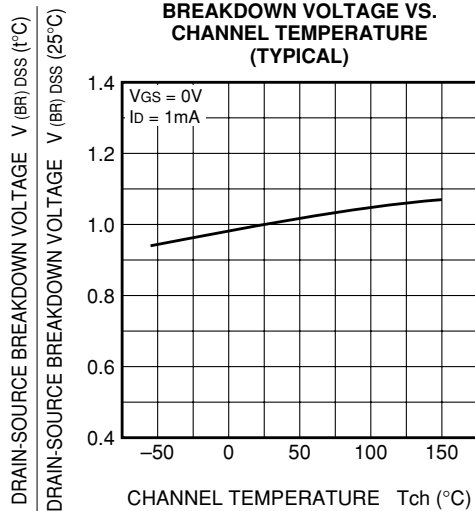
ON-STATE RESISTANCE VS.
