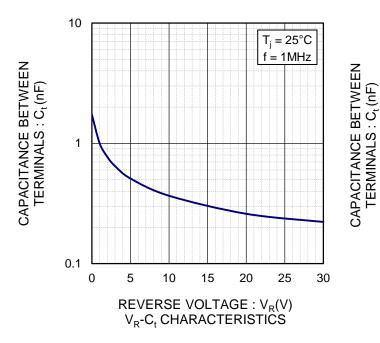


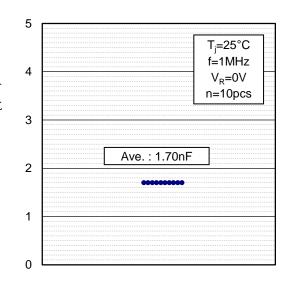


V_F DISPERSION MAP

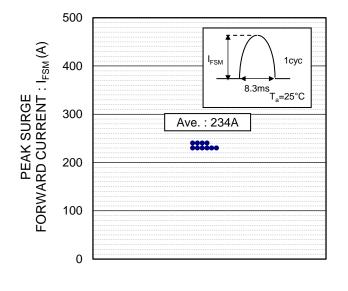
I_R DISPERSION MAP

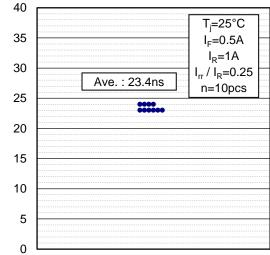




C_t DISPERSION MAP



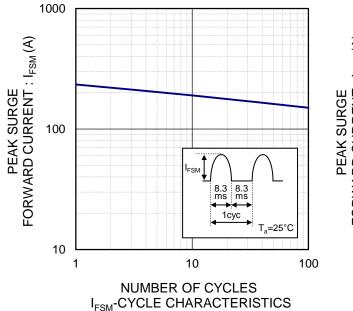
REVERSE RECOVERY TIME : $t_{\rm rr}$ (ns)

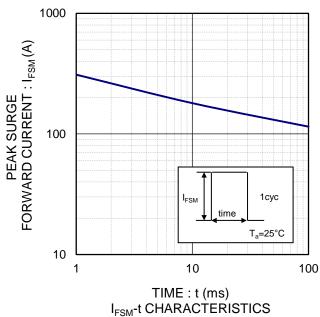


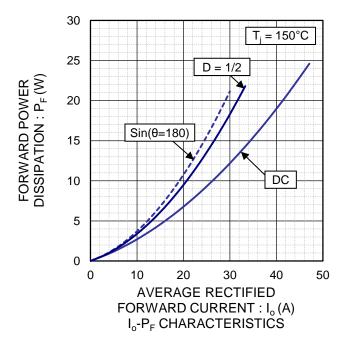
I_{FSM} DISPERSION MAP

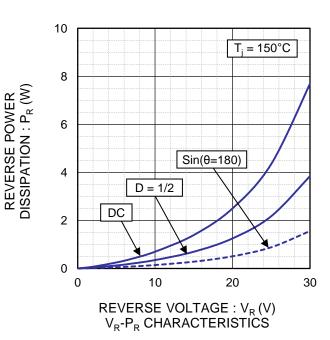
