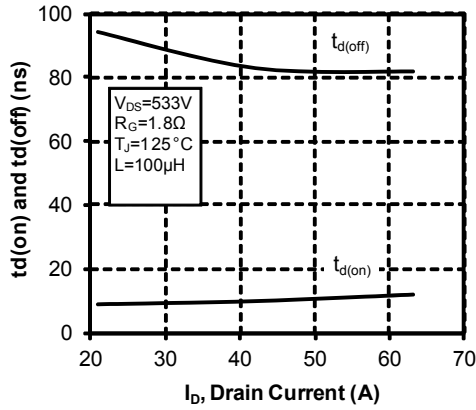

## Typical CoolMOS Performance Curve

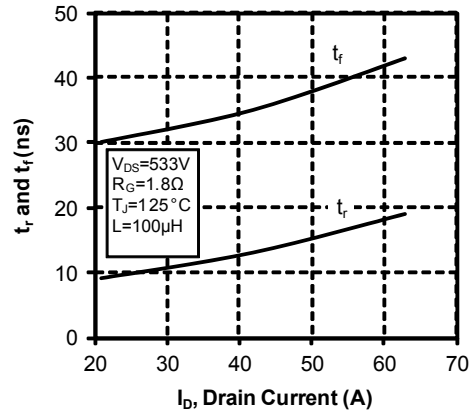




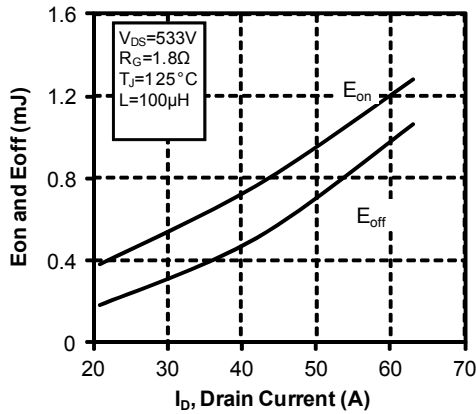
**Delay Times vs Current**



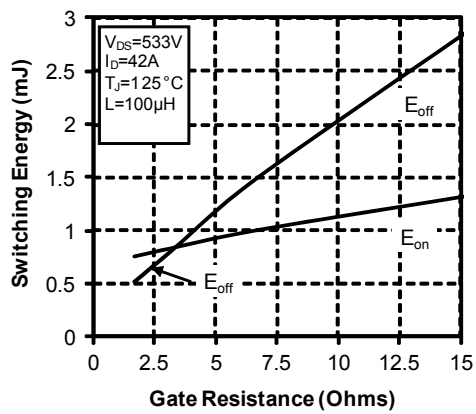
**Rise and Fall times vs Current**



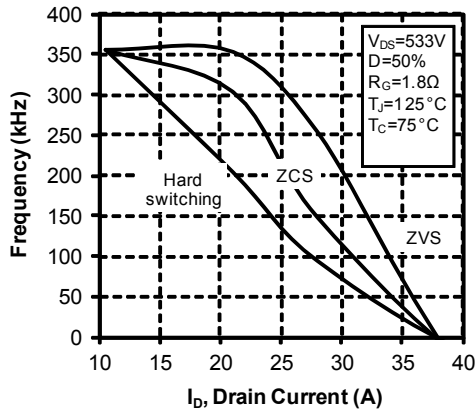
**Switching Energy vs Current**



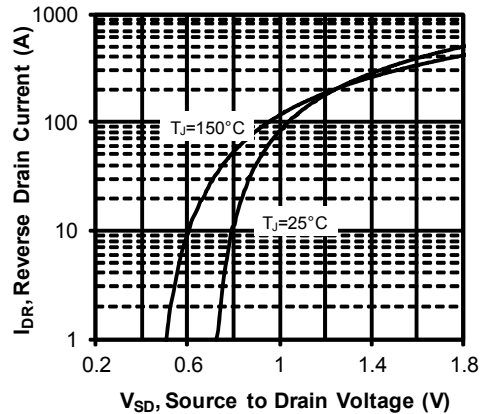
**Switching Energy vs Gate Resistance**

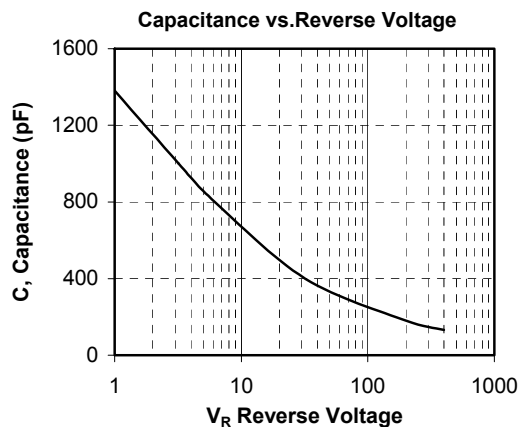
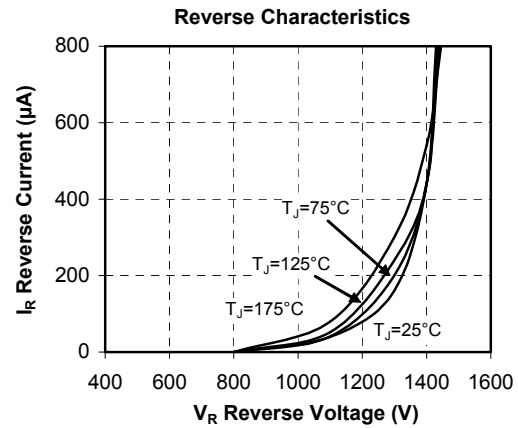
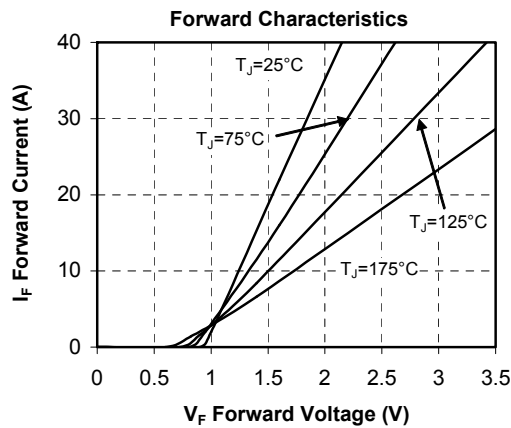
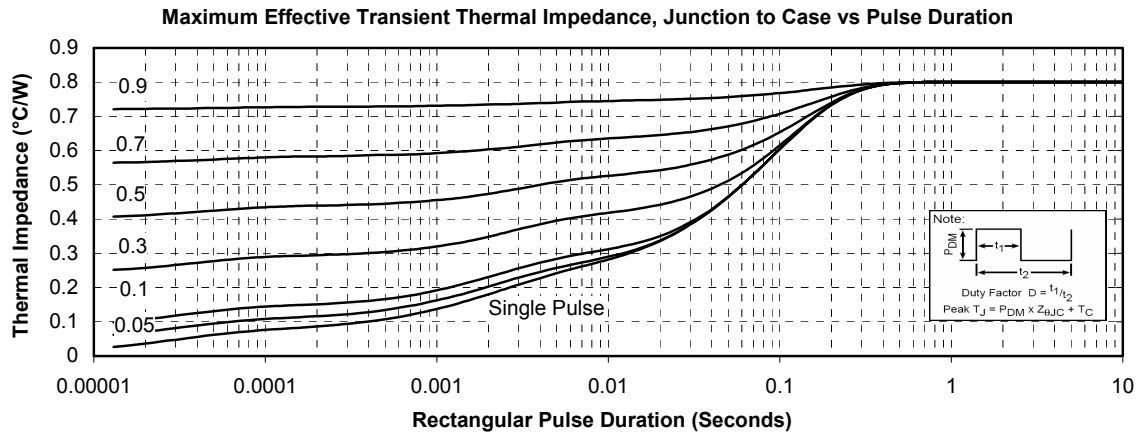


**Operating Frequency vs Drain Current**
