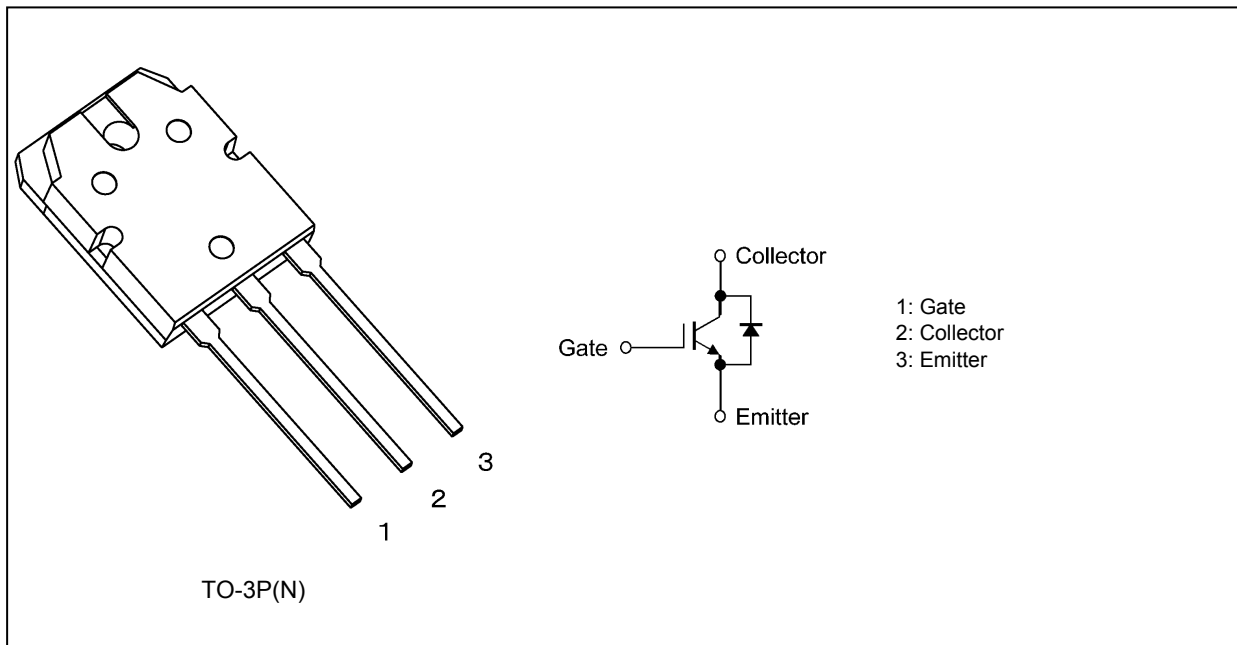

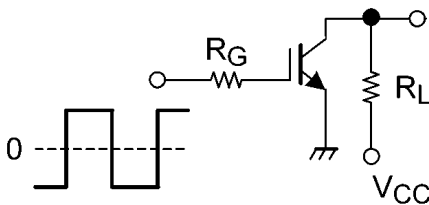


Fig. 6.2.1 Test Circuit of Switching Time

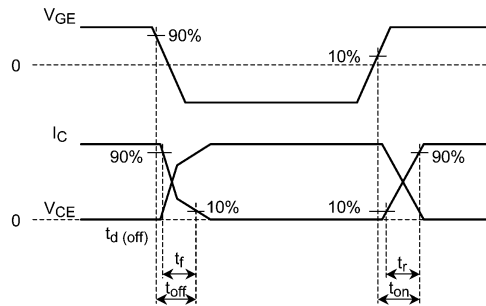


Fig. 6.2.2 Timing Chart of Switching Time

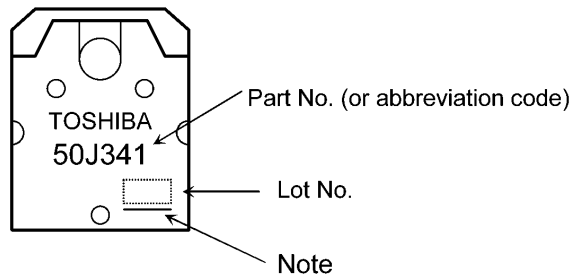


Fig. 7.1 Marking

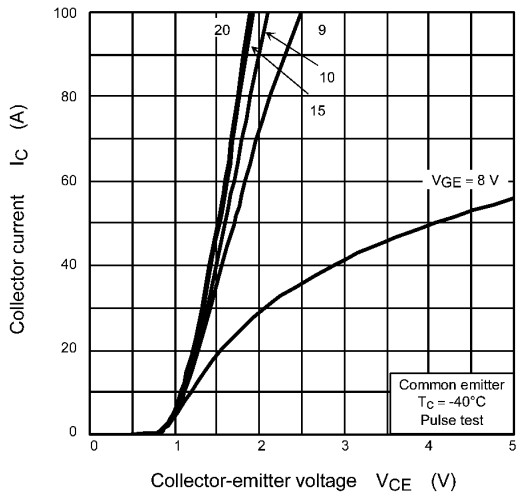


Fig. 8.1 $I_C - V_{CE}$

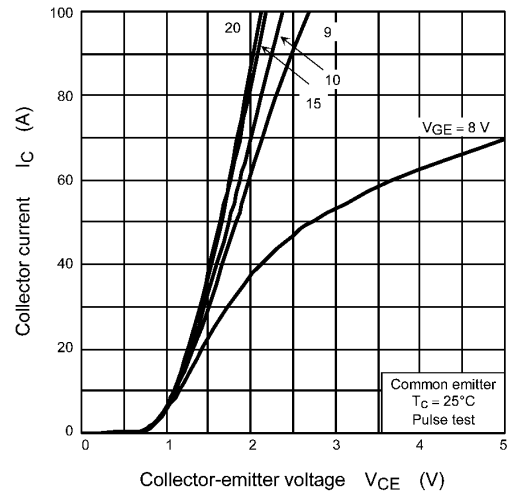


Fig. 8.2 $I_C - V_{CE}$

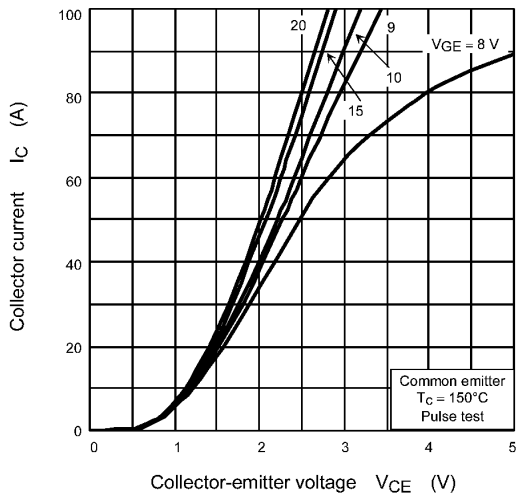


Fig. 8.3 $I_C - V_{CE}$

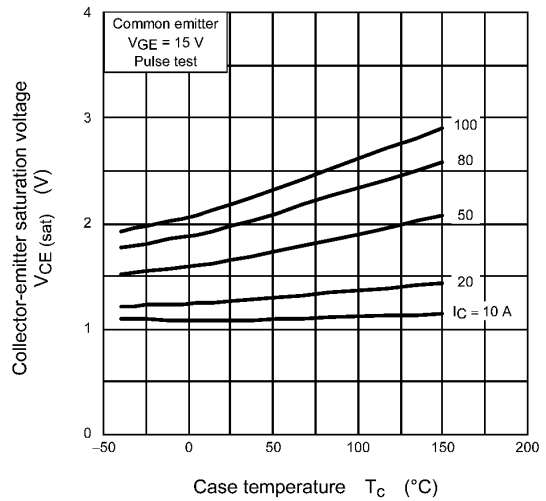


Fig. 8.4 $V_{CE(sat)} - T_C$

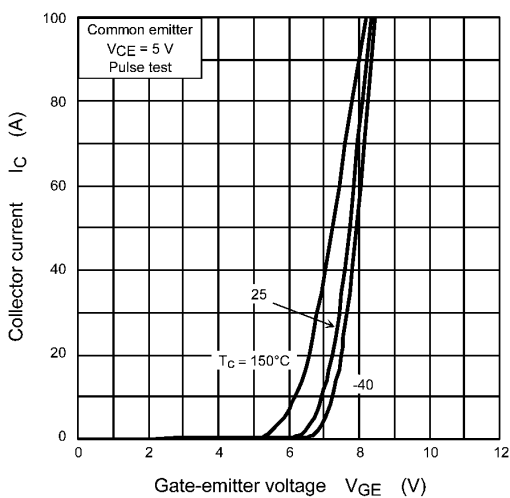


Fig. 8.5 $I_C - V_{GE}$

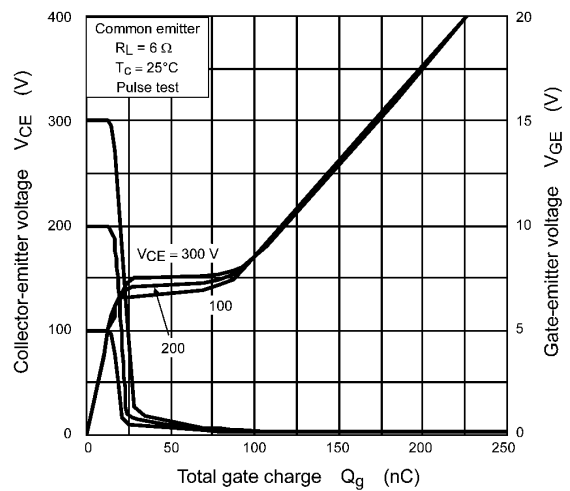


Fig. 8.6 $V_{CE}, V_{GE} - Q_g$

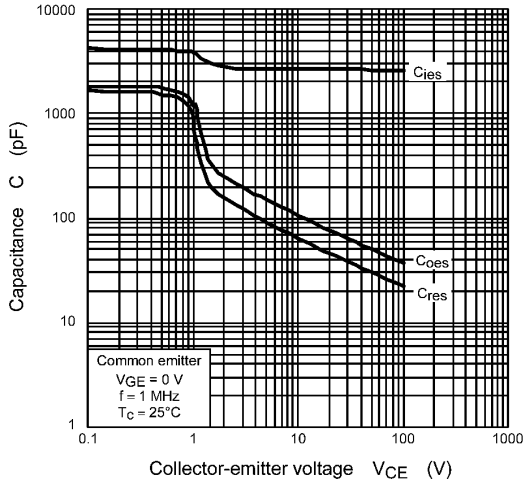


Fig. 8.7 C - V_{CE}

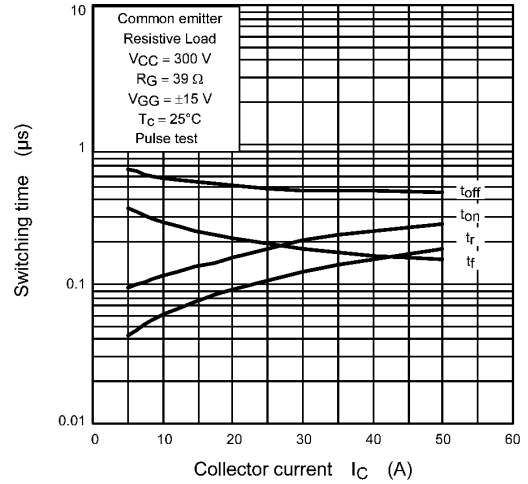


Fig. 8.8 Switching Time - I_C

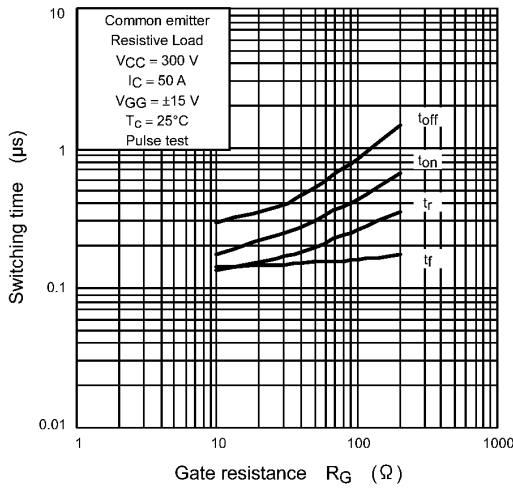


Fig. 8.9 Switching Time - R_G

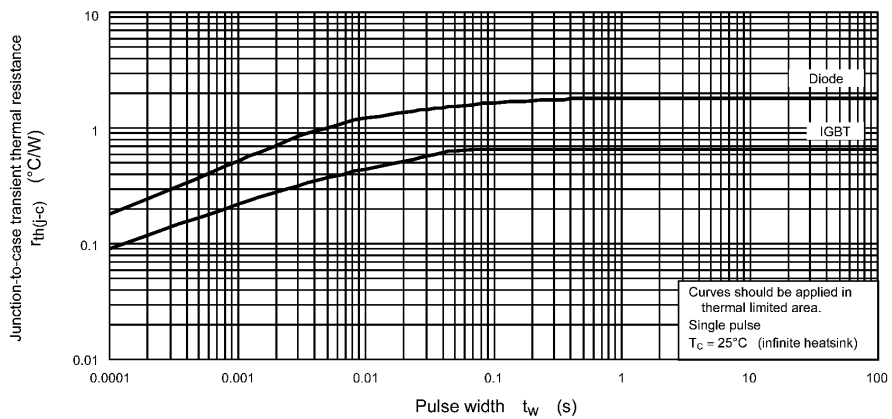


Fig. 8.10 $r_{th(j-c)} - t_w$
 (Guaranteed Maximum)

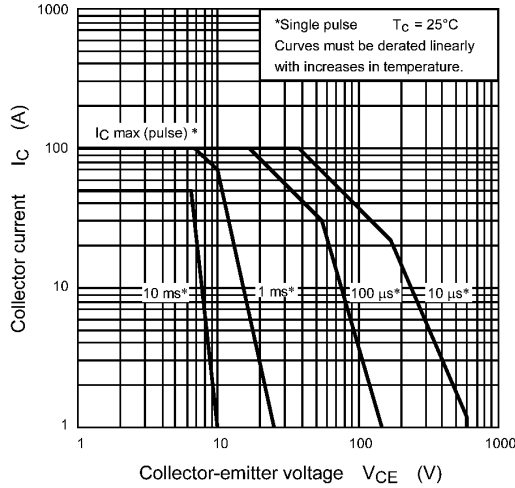


Fig. 8.11 Safe Operating Area (Guaranteed Maximum)

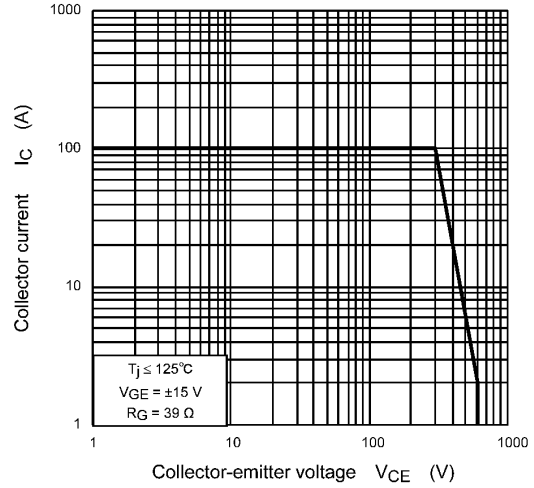


Fig. 8.12 Reverse Bias SOA (Guaranteed Maximum)

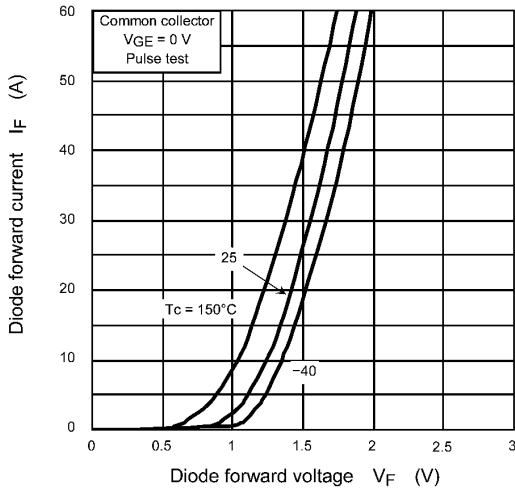


Fig. 8.13 $I_F - V_F$

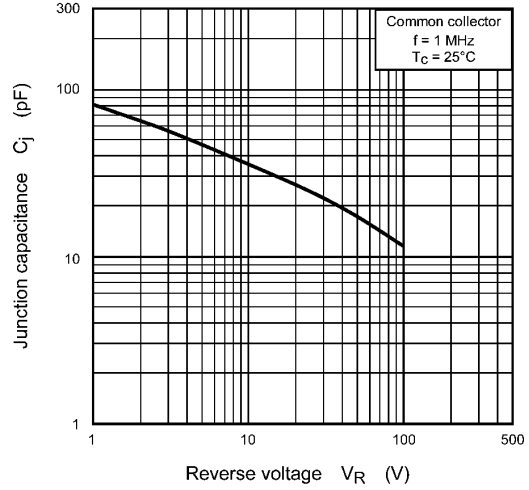


Fig. 8.14 $C_j - V_R$

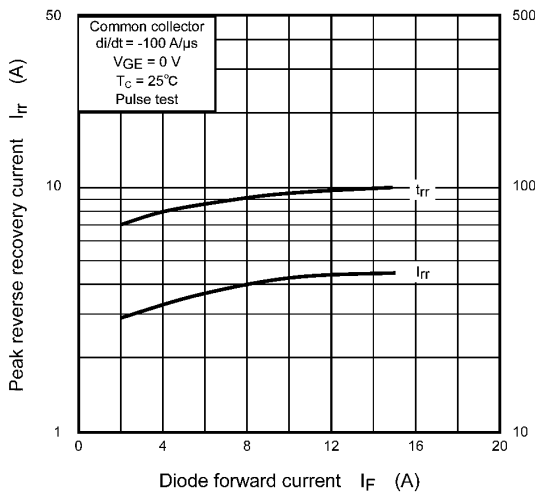


Fig. 8.15 $I_{rr}, t_{rr} - I_F$

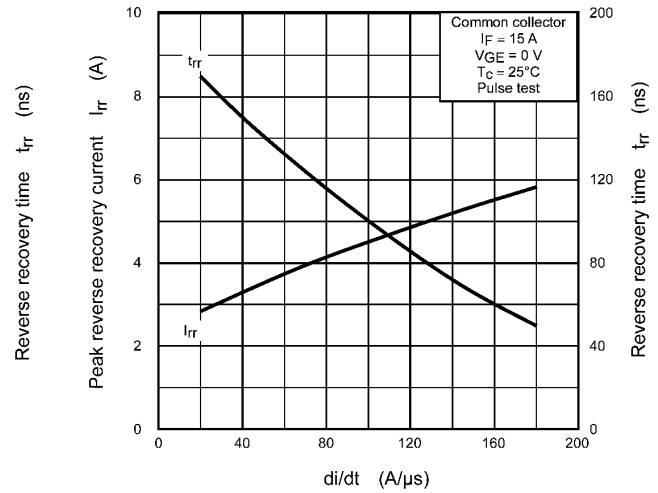
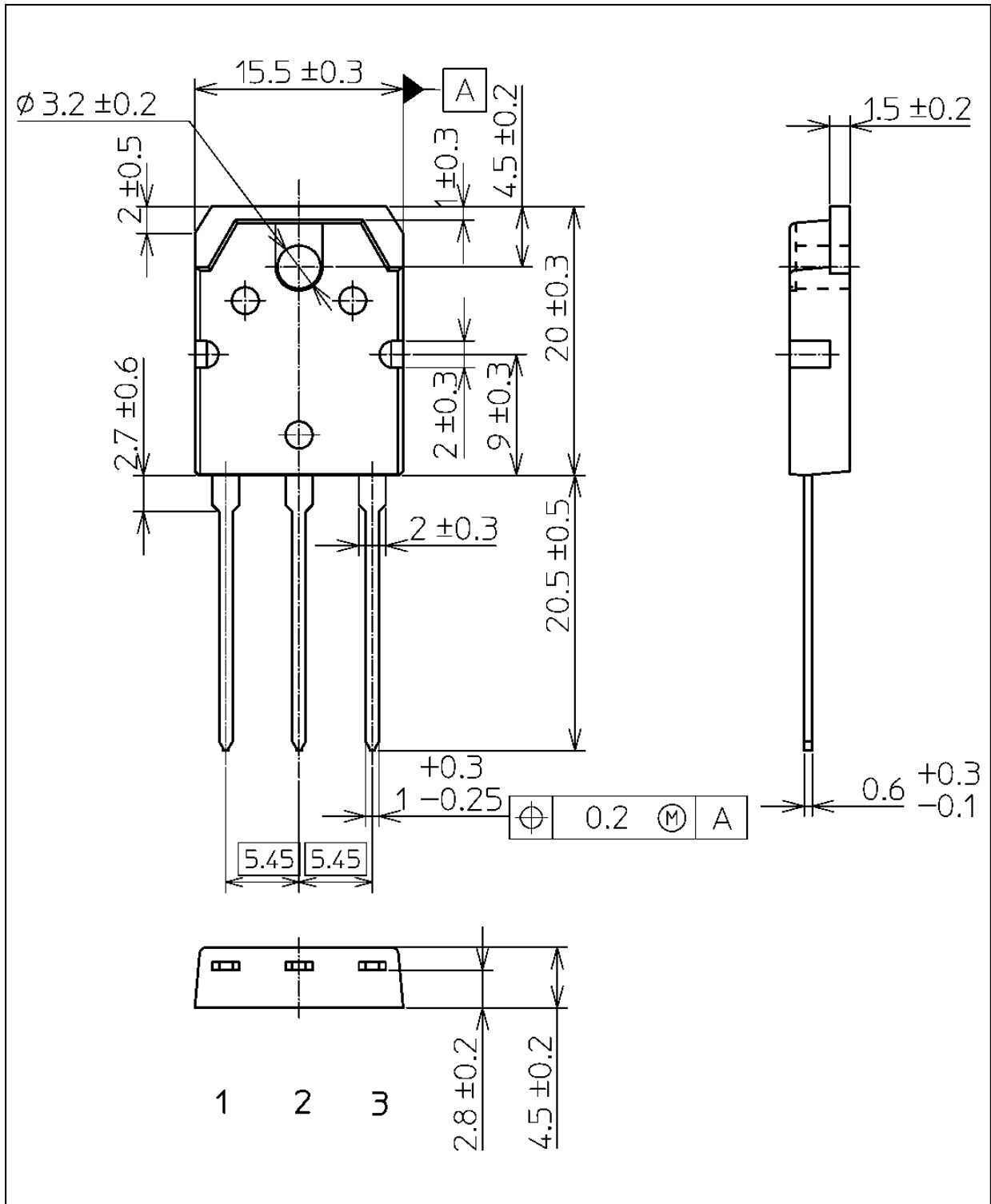


Fig. 8.16 $I_{rr}, t_{rr} - di/dt$
