Product profile 1.

1.1 General description

PESD1CAN in small SOT23 SMD plastic package designed to protect two automotive Control Area Network (CAN) bus lines from the damage caused by ElectroStatic Discharge (ESD) and other transients.

1.2 Features

- Due to the integrated diode structure only one small SOT23 package is needed to protect two CAN bus lines
- Max. peak pulse power: P_{pp} = 200 W at t_p = 8/20 μs
- Low clamping voltage: V_{(CL)R} = 40 V at I_{pp} = 1 A
- Ultra low leakage current: I_{RM} < 1 nA</p>
- ESD protection of up to 23 kV
- IEC 61000-4-2, level 4 (ESD)
- IEC 61000-4-5 (surge); I_{pp} = 3 A at t_p = 8/20 μs
- Small SMD plastic package





7. Application information

The PESD1CAN is designed for the protection of two automotive CAN bus lines from the damage caused by ElectroStatic Discharge (ESD) and surge pulses. The PESD1CAN provides a surge capability of up to 200 W per line for a 8/20 μ s waveform.



Circuit board layout and protection device placement:

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

- 1. Place the protection device as close to the input terminal or connector as possible.
- 2. The path length between the protection device and the protected line should be minimized.
- 3. Keep parallel signal paths to a minimum.
- 4. Avoid running protection conductors in parallel with unprotected conductor.
- 5. Minimize all printed-circuit board conductive loops including power and ground loops.
- 6. Minimize the length of the transient return path to ground.
- 7. Avoid using shared transient return paths to a common ground point.
- 8. Ground planes should be used whenever possible. For multilayer printed-circuit boards, use ground vias.




Fig 8. Package outline SOT23 (TO-236AB)
