### **Description:**

Maxwell Technologies' 54LVTH162245 devices are 16-bit (dual-octal) non-inverting 3-state transceivers designed for low-voltage (3.3V)  $V_{CC}$  operation, but with the capability to provide a TTL interface to a 5V system environment. These devices can be used as two 8-bit transceivers or one 16-bit transceiver. The devices allow data transmission from the A bus to the B bus or form the B bus to the A bus, depending on the logic level at the direction-control (DIR) input. The output enable (OE) input can be used to disable the device so that the buses are effectively isolated. The A-port outputs, which are designed to source or sink up to 12 mA, include equivalent 22- $\Omega$  series resistors to reduce overshoot and undershoot.

Maxwell Technologies' patented RAD-PAK® packaging technology incorporates radiation shielding in the microcircuit package. It eliminates the need for box shielding while providing the required radiation shielding for a lifetime in orbit or space mission. In a GEO orbit, RAD-PAK provides greater than 100 krad (Si) radiation dose tolerance. This product is available with screening up to Class S.





FIGURE 1. LOAD CIRCUIT




FIGURE 4. PROPAGATION DELAY TIMES INVERTING AND NONINVERTING OUTPUTS





