#### DESCRIPTION

NEC's UPB1512TU is a silicon germanium (SiGe) monolithic integrated circuit designed as a divide by 8 prescaler IC for satellite communications and point-to-point/multi-point radios.

The package is 8-pin lead-less minimold suitable for surface mount.

This IC is manufactured using our 50 GHz fmax UHS2 (<u>U</u>ltra <u>High Speed Process</u>) silicon bipolar process.














## ILLUSTRATION OF THE MEASUREMENT CIRCUIT ASSEMBLED ON EVALUATION BOARD






- 2. Back side: GND pattern



#### NOTES ON CORRECT USE

- (1) Observe precautions for handling because of electro-static sensitive devices.
- (2) Form a ground pattern as widely as possible to minimize ground impedance (to prevent undesired oscillation).
- (3) Keep the track length of the ground terminals as short as possible.
- (4) Bypass capacitance must be attached to Vcc line.
- (5) Exposed heat sink at bottom on package must be soldered to PCB RF/DC ground.
