

TAR8H01K is a bipolar type 2-system output power supply with a control pin. ON and OFF can be switched using the control pin.






The figure above shows commended configuration for using a point regulator. Insert a capacitor for stable input/output operation.


If the control function is not to be used, Toshiba recommended that the control pin be connected to the  $V_{\rm CC}$  pin.












### **NOISE Pin**


TAR8H01K device incorporate a NOISE pin to reduce output noise voltage. Inserting a capacitor between the NOISE pin and GND reduces output noise. To ensure stable operation, insert a capacitor of 0.0047  $\mu F$  or more between the NOISE pin and GND.







