


Figure 1. Max. Permissible Forward Current vs. **Ambient Temperature**




Figure 2. Forward Current vs. Forward Voltage






Figure 3. Relative Intensity vs. Wavelength




Figure 4. Rel. Luminous Intensity vs. Angular Displacement




Figure 5. Relative Luminous Intensity vs. Forward Current




Figure 6. Change of Forward Voltage vs. Forward Current




Figure 7. Change of Dominant Wavelength vs. Forward Current




Figure 8. Relative Lum. Intensity vs. Ambient Temperature






Figure 9. Change of Dominant Wavelength vs. Ambient Temperature









Figure 11. Vishay Lead (Pb)-free Reflow Soldering Profile (acc. to J-STD-020B)





Figure 12. Double Wave Soldering of Opto Devices (all Packages)



DRY PACKING

The reel is packed in an anti-humidity bag to protect the devices from absorbing moisture during transportation and storage.



FINAL PACKING

The sealed reel is packed into a cardboard box. A secondary cardboard box is used for shipping purposes.

RECOMMENDED METHOD OF STORAGE

Dry box storage is recommended as soon as the aluminum bag has been opened to prevent moisture absorption. The following conditions should be observed, if dry boxes are not available:

- Storage temperature 10 °C to 30 °C
- Storage humidity \leq 60 % RH max.

After more than 672 h under these conditions moisture content will be too high for reflow soldering.


In case of moisture absorption, the devices will recover to the former condition by drying under the following condition:

192 h at 40 °C + 5 °C/- 0 °C and < 5 % RH (dry air/nitrogen) or

96 h at 60 °C + 5 °C and < 5 % RH for all device containers or

24 h at 100 °C + 5 °C not suitable for reel or tubes.

An EIA JEDEC standard JESD22-A112 level 2a label is included on all dry bags.

ESD PRECAUTION

Proper storage and handling procedures should be followed to prevent ESD damage to the devices especially when they are removed from the antistatic shielding bag. Electro-static sensitive devices warning labels are on the packaging.
