## 1 Overview

#### Description

The TLE7272-2 is a monolithic integrated low dropout voltage regulator for load currents up to 300 mA. An input voltage up to 42 V is regulated to  $V_{Q,nom} = 5.0$  V with a precision of ±2%. Due to its integrated reset circuitry featuring power on timing and output voltage monitoring the IC is well suited as  $\mu$ -controller supply. The sophisticated design allows to achieve stable operation even with ceramic output capacitors down to 470 nF. The device is designed for the harsh environment of automotive

applications. Therefore it is protected against overload, short circuit and overtemperature conditions by the implemented output current limitation and the overtemperature shutdown circuit. The TLE7272-2 can be also used in all other applications requiring a stabilized 5 V voltage.

Due to its ultra low quiescent current of typically 20  $\mu$ A the TLE7272-2 is dedicated for use in applications permanently connected to  $V_{BAT}$ . In addition the device can be switched off via the Enable input reducing the current consumption to typically 5  $\mu$ A. An integrated output sink current circuitry keeps the voltage at the Output pin Q below 5.5 V even in case of occuring reverse currents. Thus connected devices are protected from overvoltage damage. For applications requiring extremely low noise levels the Infineon voltage regulator family TLE 42XX and TLE 44XX is more suited than the TLE7272-2. A mV-range output noise on the TLE7272-2 caused by the charge pump operation is unavoidable due to the ultra low quiescent current concept.




Figure 1 Block Diagram




Figure 2 Pin Configuration (top view)




Current Consumption  $I_{\rm q}$  versus Junction Temperature  $T_{\rm J}$ 








Current Consumption  $I_{\rm q}$  versus Input Voltage  $V_{\rm IQ}$ 




Output Voltage  $V_{Q}$  versus Junction Temperature  $T_{J}$ 










# Maximum Output Current $I_{Q}$ versus Junction Temperature $T_{j}$






#### Power Supply Ripple Rejection PSRR versus Frequency f





Load Regulation  $\Delta V_{Q}$  versus Output Current Change  $\Delta I_{Q}$ 









#### Load Regulation $\Delta V_{Q}$ versus Output Current Change $dI_{Q}$


Load Regulation  $\Delta V_{Q}$  versus Output Current Change  $\Delta I_{Q}$ 








Line Regulation  $\Delta V_{Q}$  versus Input Voltage Changed  $V_{I}$ 









Line Regulation  $\Delta V_{\text{Q}}$  versus Input Voltage Change  $V_{\text{I}}$ 


Load Transient Response Peak Voltage  $\Delta V_{Q}$ 



#### Load Transient Response Peak Voltage $\Delta V_{Q}$




Line Transient Response Peak Voltage  $\Delta V_{\rm Q}$

## 5.3 Electrical Characteristics Enable Function

The Enable Function allows disabling/enabling the regulator via the input pin EN. The regulator is turned on in case the pin EN is connected to a voltage higher than VEN,H. This can be e.g. the battery voltage, whereby no additional pull-up resistor is needed. The regulator can be turned off by connecting the pin EN to a voltage less than VEN,L, e.g. GND.





## 5.5 Electrical Characteristics Reset Function

The Reset function informs e.g. the microcontroller in case the output voltage has fallen below the lower threshold **VRT** of typ. 4.65 V. The headroom **VRH** between the output voltage and the reset threshold is typically 350 mV. Connecting the regulator to a battery voltage at first the reset signal remains LOW. When the output voltage has reached the reset threshold **VRT** the reset output RO remains still LOW for the reset delay time **tRD** (typ. 16 ms). Afterwards the reset output turns HIGH.
