Description


BPW96 is a high speed and high sensitive silicon NPN epitaxial planar phototransistor in a standard T-1 $\frac{3}{4}$ (\bigcirc 5 mm) package. Due to its waterclear epoxy the device is sensitive to visible and near infrared radiation.

The viewing angle of \pm 20° makes it insensible to ambient straylight.




Figure 1. Total Power Dissipation vs. Ambient Temperature




Figure 2. Collector Dark Current vs. Ambient Temperature






Figure 3. Relative Collector Current vs. Ambient Temperature




Figure 6. Collector Emitter Capacitance vs. Collector Emitter Voltage




Figure 4. Collector Light Current vs. Irradiance




Figure 7. Turn On/Turn Off Time vs. Collector Current




Figure 5. Collector Light Current vs. Collector Emitter Voltage




Figure 8. Relative Spectral Sensitivity vs. Wavelength







Figure 9. Relative Radiant Sensitivity vs. Angular Displacement
