


Fig. 7 - Typical Reverse Recovery Time vs.  $dI_{\mbox{\scriptsize F}}/dt$ 




Fig. 6 - Forward Power Loss Characteristics




Fig. 8 - Typical Stored Charge vs. dl<sub>F</sub>/dt




Fig. 9 - Reverse Recovery Parameter Test Circuit

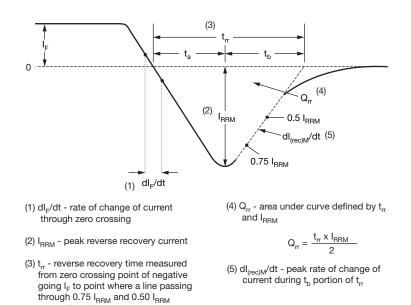


Fig. 10 - Reverse Recovery Waveform and Definitions
