#### POWER DISSIPATION DERATING CURVE




CASE TEMPERATURE Tc (°C)




DRAIN-SOURCE VOLTAGE VDS (V)

# OUTPUT CHARACTERISTICS (TYPICAL)









DRAIN-SOURCE VOLTAGE VDS (V)







