




Fig. 1 - Maximum Forward Voltage Drop Characteristics (Per Leg)




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage (Per Leg)




Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage (Per Leg)




Fig. 4 - Maximum Thermal Impedance Z<sub>thJC</sub> Characteristics (Per Leg)




Fig. 5 - Maximum Average Forward Current vs.
Allowable Lead Temperature




Fig. 6 - Maximum Average Forward Dissipation vs.
Average Forward Current




Fig. 7 - Maximum Peak Surge Forward Current vs. Pulse Duration


