





Fig.1 Input Voltage vs. Output Current (ON Characteristics)




Fig.3 Output Current vs. Output Voltage





Fig.2 Output Current vs. Input Voltage (OFF Characteristics)

Fig.4 DC Current Gain vs. Output Current



# • Electrical characteristic curves ( $T_a = 25^{\circ}C$ )






