






### • Electrical characteristic curves(T<sub>a</sub> = 25°C)



### Fig.1 Ground Emitter Propagation Characteristics


Fig.2 Typical Output Characteristics



COLLECTOR TO EMITTER VOLTAGE :  $V_{\text{CE}}\left[V\right]$ 


## Fig.3 DC Current Gain vs. Collector Current (I)

DC CURRENT GAIN : hFE




COLLECTOR CURRENT : Ic [mA]


Fig.4 DC Current Gain vs. Collector Current (II)




## • Electrical characteristic curves(T<sub>a</sub> = 25°C)




# Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





## Fig.8 Gain Bandwidth Product vs. Emitter Current





