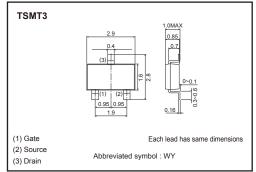

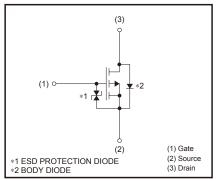

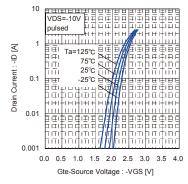


Fig.1 Typical Transfer Characteristics

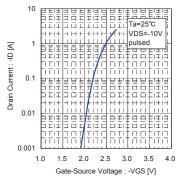


Fig.2 Typical Transfer Characteristics

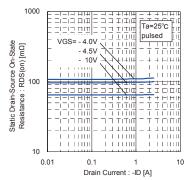


Fig.3 Static Drain-Source On-State Resistance vs. Drain Current

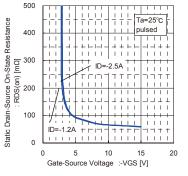


Fig.4 Static Drain-Source On-State Resistance vs. Gate-Source Voltage

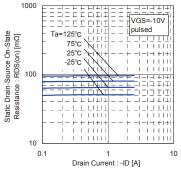


Fig.5 Static Drain-Source On-State Resistance vs. Drain Current

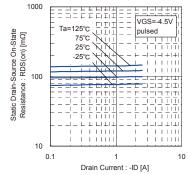


Fig.6 Static Drain-Source On-State Resistance vs. Drain Current

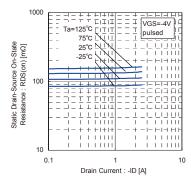


Fig.7 Static Drain-Source On-State Resistance vs. Drain Current

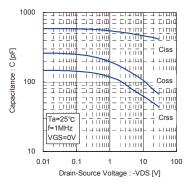


Fig.8 Typical Capacitance vs. Drain-Source Voltage

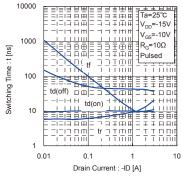
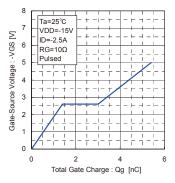


Fig.9 Switching Characteristics





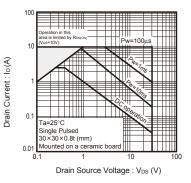


Fig.11 Safe operating area

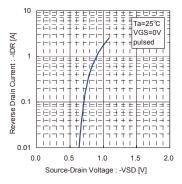


Fig.12 Reverse Drain Current vs. Source-Drain Voltage

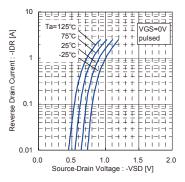


Fig.13 Reverse Drain Current vs. Source-Drain Voltage
